### **TUITION RATES BEGINNING MONDAY, JUNE 5, 2017**

**CUDDLE BUGS I** (Newborn – 18 months)-\$235.00/week *plus* a one-time registration fee.

Infant registration fees will vary depending upon the length of time that a space is held.

**CUDDLE BUGS TODDLERS** (18 – 24 months)-\$215.00/week *plus* a one-time \$75.00 registration fee.

**CUDDLE BUGS TWO'S** (2 year olds)-\$205.00/week *plus* a one-time \$75.00 registration fee.

**CATERPILLARS & BUTTERFLIES** (3-5 year olds)-\$195.00/week *plus* a one-time \$75.00 registration fee.

### **SCHOOL AGE ADVENTURE CLUB:**

Before – before school care and transportation to Linn Mar elementary school: \$55.00/week plus a one-time \$40.00 registration fee.

After - after school care and transportation from Linn Mar elementary school: \$55.00/week plus a one-time \$40.00 registration fee.

Before & After - includes both programs: \$110.00/week plus a one-time \$40.00 registration fee.

If childcare services are used, your tuition will be adjusted accordingly.

Holiday/In-service Daily Fee: \$37.00.

Holiday Weekly Fee: \$185.00.

Late Start or Early Dismissal: \$18.50/day plus Before and/or After tuition.

2017 Summer Weekly Fee: \$185.00/week plus a one-time \$95.00 materials/field trip fee.

**MWF PRESCHOOL TUITION** - September 2017 through May 2018 school year \$160.00/month.

**CHILDCARE TUITION and MWF PRESCHOOL** - \$195.00/week, *plus* cost of preschool.

**T-TH PRESCHOOL TUITION** - September 2017 through May 2018 school year \$145.00/month.

**CHILDCARE TUITION and T-TH PRESCHOOL** - \$195.00/week, *plus* cost of preschool.

### **YEARLY FEE - non-refundable**

- MWF Preschool Registration/Materials Fee - \$95.00/year.
- T-TH Preschool Registration/Materials Fee - \$75.00/year.

### **PAYMENT POLICIES**

1. ***Only full-time childcare*** is entitled to seven holidays (New Year's Day, Good Friday, Memorial Day, Fourth of July, Labor Day, Thanksgiving and Christmas). When figuring how much to deduct for a holiday take your weekly charge and divide it by 5. ***Part-time childcare*** is not entitled to holidays and is not allowed to change days of care without an additional charge.
2. If Little Learners makes the decision to close the entire facility due to inclement weather, all charges will be adjusted accordingly.
3. Full payment for the current week of childcare is due on or before 5:30 p.m., Friday of the current week. Your account will incur a \$25.00 late payment fee if payment is received after the due date **and** service will be terminated at the end of the week unless the account is paid in full.\*
4. Full payment for all preschool programs is due the first Friday of every month. Your account will incur a \$25.00 late payment fee if payment is received after the due date **and** service will be terminated at the end of the week unless the account is paid in full.\*
5. ***Unless prior arrangements have been made***, Little Learners hours are 7:00 a.m. until 6:00 p.m. A \$15.00 late pick-up fee will be charged for each 15 minutes or portion thereof beyond the designated closing time of 6:00 p.m.
6. Voluntary cancellation of service by you requires a two-week advance *written* notice.
7. Rate changes because of a birthday take effect on the Monday following the birthday.

*\*Unless due to illness on the tuition due date, which has been reported to the school office on the day of absence, late payment fees will not be waived.*
